Nominators must conform to the requirements outlined below in order for their nomination to be considered for a Wright Spirit Award. The Wright Spirit Awards will be presented during the Gala Dinner and Awards Ceremony at the annual conference of the Frank Lloyd Wright Building Conservancy. Each honoree will receive an etched crystal Wright Spirit Award designed by Susan Jacobs Lockhart with the compliments of J. Charles Crystalworks.

The Frank Lloyd Wright Building Conservancy reserves the right not to present an award in one or all of the categories during a given year.

NOMINATION REQUIREMENTS

- A completed Wright Spirit Award nomination form. All complete nominations will become the property of the Frank Lloyd Wright Building Conservancy. Please note that incomplete nominations will not be accepted and will be returned to the nominator.
- A concise 300-word description of the project, program, organization, or individual that is being nominated and how the nominee fulfills the requirements for the individual category.
- Up to 10 supporting documents, such as photographs, newspaper or journal articles, brochures, and the like may be attached to the nomination. *Please do not include original materials*.
